RESTATED
ARTICLES OF ORGANIZATION
OF
VENTUREX MANAGEMENT, L.L.C.

- I. The dated of filing of the Articles of Organization of VENTUREX MANAGEMENT, L.L.C. was October 25, 2001.
- II. The undersigned, consisting of all Members of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby adopts the following Restated Articles of Organization for such Limited Liability Company:

ARTICLE I - NAME

The name of the limited liability company shall be VENTUREX MANAGEMENT, L.L.C. (the "Company").

ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS

New Members shall be admitted only with the unanimous consent of, and upon terms unanimously approved by, all of the Members.

ARTICLE VI - MEMBERS' RIGHTS TO CONTINUE BUSINESS

In the event of the death, retirement, resignation, expulsion, withdrawal, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued on approval of all of the remaining Members (other than the terminated Member and such member's successors-in-interest).
