# RESTATED ARTICLES OF ORGANIZATION OF VENTUREX MANAGEMENT, L.L.C.

- I. The date of filing of the Articles of Organization of VENTUREX MANAGEMENT, L.L.C. was October 25, 2001 and the date of filing of the Restated Articles of Organization of VENTUREX MANAGEMENT, L.L.C. was August 29, 2002.
