

# A Florida Limited Liability Company

- 1. Name. The name of the limited liability company shall be "RIVERWOOD PROPERTIES, LLC" (the "Company").
- 2. <u>Registered Address and Agent</u>. The address of the Company's registered office, and the name of the Company's registered agent at such office, in the State of Florida are as follows:
