ARTICLES OF ORGANIZATION OF R.W. JOYNER & SONS, L.L.C.

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLEI

NAME

The name of the limited liability company, hereinafter referred to in these Articles as "R.W. Joyner & Sons, L.L.C.," herein referred to as the "Company."

ARTICLE II ADDRESS

ARTICLE VI RESTRICTIONS ON MEMBERSHIP
