ARTICLE I.

PREAMBLE; FORMATION

The undersigned, TRIPLE DIAMOND ENTERPRISES, L.L.C., by CARL HEINSMAN, its Member, and GREG LOVE, do hereby form a Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, titled as the "Florida Limited Liability Company Act," as hereinafter set forth.

ARTICLE II.

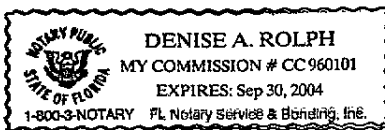

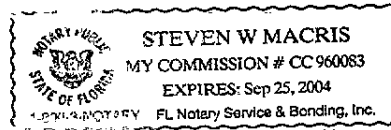
