##### MANAGEMENT

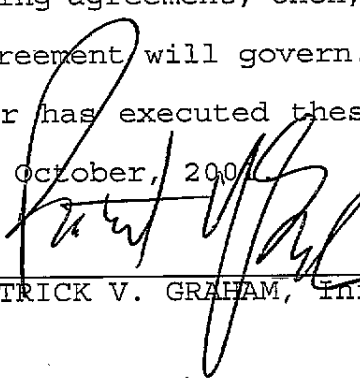
