ARTICLES OF ORGANIZATION
OF
CT MANAGEMENT, L.L.C.

The undersigned, acting as organizer and as the authorized representative of a member of CT Management, L.L.C., under Section 608.407 of the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization:

ARTICLE I: NAME

The name of this limited liability company (the "Company") is CT Management, L.L.C.

ARTICLE II: ADDRESS

ARTICLE III: INITIAL REGISTERED OFFICE AND AGENT

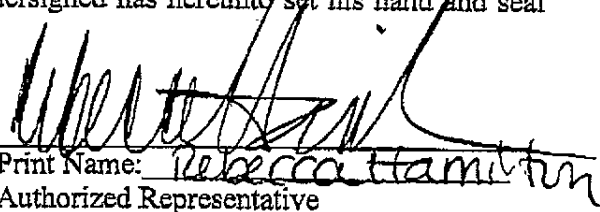
