**ARTICLE II**

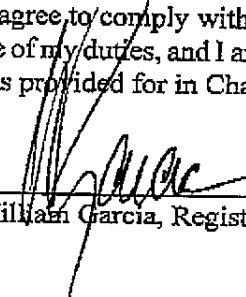

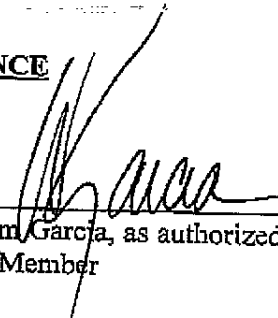
