OF

**ARTICLE I
Name**

The name of the limited liability company ("Company") is WILKINSON ENTERPRISES, LLC.

**ARTICLE II
Address**

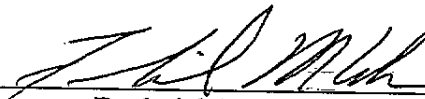
ARTICLE VII

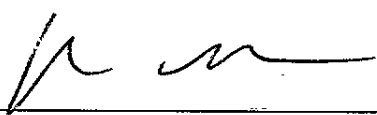
