ARTICLES OF ORGANIZATION OF WILKINSON ENTERPRISES, LLC

ARTICLE I Name

The name of the limited liability company ("Company") is WILKINSON ENTERPRISES, LLC.

ARTICLE II Address

The mailing and street address of the Company's principal office is 1252 Ponte Vedra Boulevard, Ponte Vedra Beach, FL 32082.

ARTICLE III Duration

The period of duration for the Company is limited to 50 years after the filing of these articles with the Division of Corporations.

ARTICLE IV Registered Agent and Office

The name of Company's initial registered agent in Florida is Kimberly A. Blankenship, Esquire. The address of Company's registered office in Florida is 1300 Marsh Landing Parkway, Suite 108, Jacksonville Beach, FL 32250-2407.

ARTICLE V Management

The Company is to be managed by managers. Each initial manager will serve until the first annual meeting of the members. The initial managers are identified as follows:

ARTICLE VI Admission of New Members

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE VII Termination of Business

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE VIII Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company vested entirely in the managers listed in Article V.
