The name of the Limited Liability Company is: BIG CAT'S CONTRACTOR SERVICES, LLC.

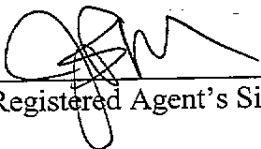
ARTICLE 11 - ADDRESS

ARTICLE VI - ADDITIONAL MEMBERS

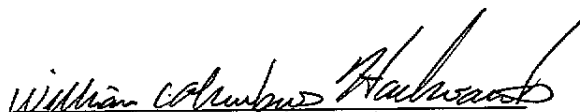
The members have the right to admit additional members upon terms and conditions to be determined in a subsequent date.
