Article V

OPERATING AGREEMENT; MEMBERS' AGREEMENT.
At the time of executing these Articles of Organization, the members of the Company shall adopt an Operating Agreement containing all provisions for the regulation and management of this Company not inconsistent with law or these Articles. The power to alter, amend or repeal the Operating Agreement shall be vested in the members of this Company. The members of the Company also may adopt a members' agreement containing mutually accepted guidelines regarding the administration and governance of the Company and provisions governing the transfer of membership interests.

Article VI

TRANSFER OF INTEREST. No member shall have the right to transfer any interest in the Company unless authorized by vote of the members representing a majority of the membership interests in the Company or otherwise as may be provided in any Members' Agreement.

Article VII

CERTIFICATED INTERESTS. The members' membership interests in the Company may be evidenced by certificates.

Article VIII

AMENDMENTS. These Articles, except with respect to the vested rights of the members, may be amended from time to time by a vote of members representing a majority of the membership interests of the Company. All members of the Company agree to abide by the majority decision and agree to sign the certificate of amendment corresponding to such amendments for the purpose of filing with the Florida Department of State, consistent with the Act.
