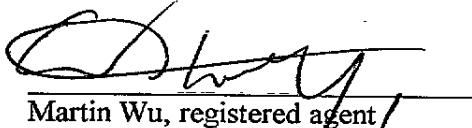
ARTICLE 1. The name of this limited liability company shall be: **Orlando Leisure Development Group, LLC.**

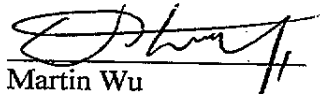
