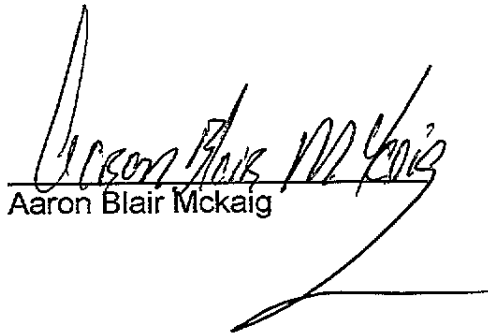
## ARTICLE VII
