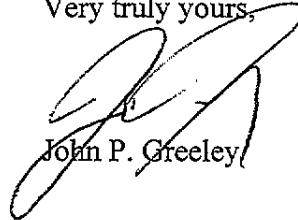

ARTICLES OF ORGANIZATION

OF

FBCH LLC

The undersigned, desiring to organize this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE I - NAME

The name of the limited liability company shall be FBCH, LLC (the "Company").

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

The mailing address and street address of the principal office of the Company is: 3838 North Tamiami Trail, 2nd Floor, Naples, FL 34103.

ARTICLE III - DURATION

ARTICLE VII - ADDRESS AND REGISTERED AGENT

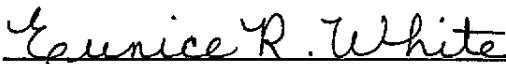
