ARTICLES OF ORGANIZATION of PARADISE COVE, LLC

a Florida Limited Liability Company

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Act, Florida Statutes Chapter 608.

ARTICLE I – Name:
