#### ARTICLES OF ORGANIZATION

OF

#### J BAR J, LLC

The undersigned, for the purpose of forming a limited liability company inder the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be J BAR J, LLC, ("Company").
