

Pursuant to the provision of Section 608.411, Florida Statutes, this Florida Limited Liability Company adopts the following amendment to its Articles of Organization:


**ARTICLE I - ORGANIZATION NAME**

The amendment was adopted by the board of managers and members without member action and member action was not required.

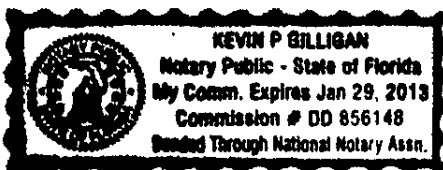
