#### ARTICLES OF ORGANIZATION

## SOUND DYNAMICS, L.L.C., a Florida limited liability company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

## ARTICLE I: NAME

The name of the Limited Liability Company is **Sound Dynamics**, L.L.C., a Florida limited liability company (the "Limited Liability Company").

#### ARTICLE II: DURATION

Additional contributions, if any, will be made upon unanimous agreement of the members of the Limited Liability Company.

# ARTICLE VIII: ADDITIONAL MEMBERS

Members may admit additional members upon unanimous agreement of the members in the Limited Liability Company.

# ARTICLE IX: CONTINUITY OF BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of ar member in the Limited Liability Company, the business of the Limited Liability Company shall be continued and the Limited Liability Company shall not be dissolved unless the consent to dissolve of all the remaining members of the Limited Liability Company is obtained or these Articles of Organization are amended thereby providing for the continued existence of the Limited Liability Company subsequent to the foregoing events.

## ARTICLE X: REGULATIONS

The member(s) shall have the power to adopt, alter, amend or repeal regulations of the Limited Liability Company containing provisions for the regulation and management of the affairs of the business of the Limited Liability Company.
