ARTICLES OF ORGANIZATION
OF
TRAVIS ENTERPRISES, LLC

The undersigned, ROYAL TRAVIS as subscriber to these Articles of Organization, hereby present these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 608.

ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability company shall be TRAVIS ENTERPRISES, LLC.

ARTICLE II.
TERM OF EXISTENCE

The existence of this limited liability company shall commence upon the date of filing of these Articles of Organization with the Department of State, State of Florida, and shall terminate thirty (30) years thereafter or upon the earlier termination in accordance with these Articles of Organization or otherwise in accordance with the laws of the State of Florida.

ARTICLE III.
BUSINESS OF LIMITED LIABILITY COMPANY

3.1 Specific Business: To purchase, acquire, hold, maintain and manage personal and real property for investment purposes.

3.2 General Business: This limited liability company is organized for the purpose of transacting any and all lawful business, together with and in addition to those powers conferred by the laws of the State of Florida, and the principles of common law upon limited liability companies organized and existing under and by virtue of the laws of Florida.

3.3 The limited liability company shall purchase for its use, either as business locations or for investment and resale, real property of any tenure and any interest therein, and to create, sell and deal in freehold or leasehold ground rents and to make advances upon the security of land or buildings, or other property, or any interest therein, and to take and hold title to land, tenements, and buildings, and to sell and convey the same.

3.4 The limited liability company shall borrow and contract debts when necessary, either for transaction of its business, or for the exercise of its corporate rights, privileges and franchises, or for any other lawful purpose of its organization; to issue bonds, promissory notes, bills of exchange, debentures, and other obligations and evidence of indebtedness, whether secured by mortgage or otherwise, or unsecured, either for the purpose of investment, conduct of its business, or other lawful objects;

3.5 The limited liability company shall employ, generally agents, whether members or officers of this limited liability company or otherwise, and to transact any and all business which may be necessary, incidental, or proper to the exercise of any or all of the aforesaid purposes of the Limited liability company; to exercise generally such powers as may be incidental or convenient for any of the purposes or businesses of the limited liability company; to have, exercise, and enjoy all of the rights and privileges of limited liability companies for profit conferred by the laws of the State of Florida and all amendments thereto.

3.6 The foregoing clauses shall be construed both as powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit the powers of the limited liability company, and each power and object shall be construed as if named separately and alone and shall not be limited in any way because of the naming of any other power or object.

ARTICLE IV. PRINCIPAL PLACE OF BUSINESS

The principal place of business, mailing address and initial registered office of the limited liability company shall be 9191 Bay Pines Boulevard, St. Petersburg, Florida 33708, located in Pinellas County, Florida, but the limited liability company shall have the power to establish branch offices and other places of businesses at such other place or places within or without the State of Florida as may be determined and deemed expedient.

ARTICLE V. INITIAL REGISTERED AGENT

The initial Registered Agent of the limited liability company shall be the following named person at the following address:

ARTICLE VI. CAPITAL CONTRIBUTION

The initial capital contributed by each Member of the limited liability company shall be the sum of \$500.00. Each member shall pay, from time to time, additional cash contributions in equal sums and in such amounts as may be needed by the limited liability company for business purposes.

ARTICLE VII. MEMBERSHIP

7.1 Initial Members: The initial members of the limited liability company shall be ROYAL TRAVIS, DAVID TRAVIS, CHRISTOPHER TRAVIS, RICHARD TRAVIS and TIMOTHY TRAVIS.

7.2 Additional Members: Additional members may be admitted to the limited liability company, subject to the following terms, provisions, and conditions:

7.1.1 The admission of any additional members to the limited liability company shall be approved, in writing, by all current and existing members.

7.1.2 Any additional members shall contribute cash, or the equivalent thereof, equal to the contribution made by each existing member, as stated and described in these Articles of Organization, or such other amount as shall be mutually agreed upon, in writing, by any such additional member and all existing members of the limited liability company.

7.3 Business Continuation: The remaining and surviving members shall have the right to continue the business of the limited liability company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member; or the occurrence of any other event that terminates the continued membership of a member.

7.4 Unauthorized Acts of Members: A Member is specifically prohibited from entering into any of the following contracts or transactions:

7.4.1. A Member is prohibited from engaging in any act in contravention of this Agreement.

7.4.2. A Member is prohibited from engaging in any act which makes it impossible to carry on the ordinary business of the limited liability company.

7.4.3. A Member is prohibited from confessing a judgment against the limited liability company.

7.4.4. A Member is prohibited from possessing limited liability company property or assigning rights and specific partnership property for other than a limited liability company purpose.

7.4.5. A Member is prohibited from taking any action in the name of or on behalf of the limited liability company without the authorization of a majority vote of the Members.
