**ARTICLES OF ORGANIZATION
OF

The undersigned member or authorized representative of a member of this company declares that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

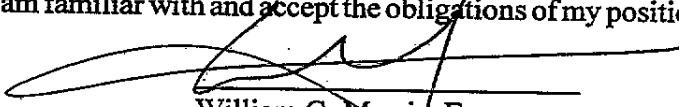
