ARTICLES OF ORGANIZATION FOR

THE NEMESIS GROUP, LLC

The undersigned, acting as the organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I Name

ARTICLE V Registered Agent and Office

The initial registered agent for the Company for service of process shall be ANTHON HUESTON, III, and the address of the registered agent shall be 5745 Manatee Avenue West Suite 82, Bradenton, Florida 34209.

ARTICLE VI Management of Business

The Company shall be managed by a Manager or Managers. ANTHONY HUESTON, III of 5745 Manatee Avenue West, Suite 82, Bradenton, Florida 34209, and ALLAN JOHNSTON of 5757 Manatee Avenue West, Bradenton, Florida 34209 will serve as Managers of the Company until their successors are elected and qualified as provided in the Operating Agreement. The Managers are hereby authorized to convey and encumber title to all real and personal property of the Company, borrow moncy or obtain other financial accommodations for the Company, create security interests in any property of the Company, and to otherwise deal with the assets and property of the Company in any manner which the Managers deem appropriate. In furtherance of such authorization, the Managers shall have the authority to execute on behalf of the Company any and all agreements, deeds, mortgages, security interests, conditional sales contracts, trust agreements, indentures, leases, conveyance documents, and all other certificates, instruments, affidavits, and documents as are necessary, reasonable or desirable to convey or encumber title to any real or personal property of the Company and otherwise conduct the business of the Company. The signature and execution of such documents by the Managers shall clearly set forth that the execution is on behalf of the Company, and that the Managers are signing on behalf of the Company. Third parties may rely upon the execution of such documents by the Managers as binding on the Company without further inquiry, consent, or approval.

ARTICLE VII Admission of Additional Members

Additional Members may be admitted only by a vote of the Members owning a majority of the outstanding voting Units, upon terms and conditions established by the Members from time to time in their sole discretion.

ARTICLE VIII Membership

The Company shall have only one class of Membership, and the rights, obligations, and responsibilities associated with Membership shall be set forth in the Operating Agreement for the Company.

ARTICLE IX Powers

The Company shall have all of the powers and authority set forth in Section 608.404 of the Act unless limited by these Articles of Organization or the Operating Agreement.

ARTICLE X Property

- (a) <u>Ownership.</u> All property originally paid or transferred to the Company as contributions to capital by the Members, or subsequently acquired by purchase or otherwise on account of the Company, shall be the property of the Company.
- (b) <u>Title.</u> The title to all property of the Company shall be held in the name of the Company.

ARTICLE XI Amendments

These Articles may be amended or restated at any time by a vote of the Members owning a majority of the outstanding voting Units, and such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 608.411 of the Act.

ARTICLE XII Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles unless

permitted herein. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth therein.
