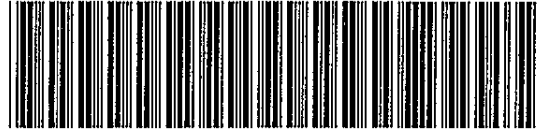


FIRST: The Articles of Organization were filed on 11/13/2001 and assigned document number L01000019586.
