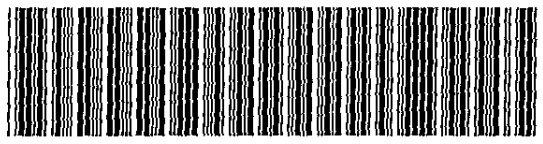

**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF ORGANIZATION  
OF TRI-COUNTY ANESTHESIA VOLUSIA CHARTERED**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida company hereby adopts the following Articles of Amendment to its Articles of Organization:

**Article I - Name and Date of Filing**


**Article III - Effective Date of Amendment**
