The principal place of business and mailing address of the Company is 4501 Beverly Avenue, Jacksonville, Florida 32210.


ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

The name and street address of the initial registered agent is Kenyon S. Atlee, 4501 Beverly Avenue, Jacksonville, Florida 32210.


ARTICLE IV - MANAGERS

The Company shall be a manager-managed company as provided in the Operating Agreement.


