ARTICLES OF ORGANIZATION OF

OLD CUTLER DEVELOPERS, LLC

A Florida Limited Liability Company

The undersigned, a natural person, does hereby form a Limited Liability Company under Florida Statutes §608, and other laws of the State of Florida.

ARTICLE 1 NAME


The name of this limited liability company is **Old Cutler Developers, LLC**, referred to in these Articles of Organization as the "**COMPANY**".

ARTICLE 2 REGISTERED OFFICE AND AGENT
