ARTICLES OF ORGANIZATION

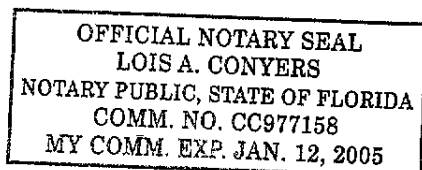


