

The Members may admit additional Members to the company as they may be determined by majority vote.


ARTICLE VIII – CONTINUITY OF BUSINESS





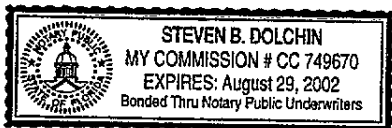
