

## ARTICLES OF ORGANIZATION

### OF

## REIS SEARCH ASSOCIATES, LLC

The undersigned, acting as the organizers of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby form a limited liability company under the laws of the State of Florida and adopt the following Articles of Organization for such Limited Liability Company:

### ARTICLE I - NAME

The name of the limited liability company shall be Reis Search Associates, LLC (the "Company").

### ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

The number of managers of the Company shall be the number from time to time fixed by the members, or the managers, in accordance with the terms and conditions of the Operating Agreement of the Company.



ARTICLE VI

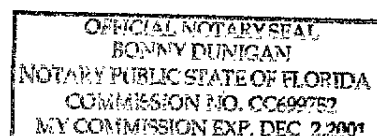


