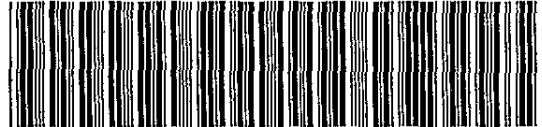



FIRST: Amendments and restatements adopted:

ARTICLE 1
NAME



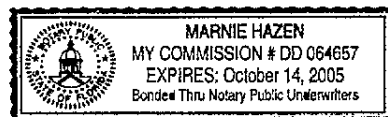
