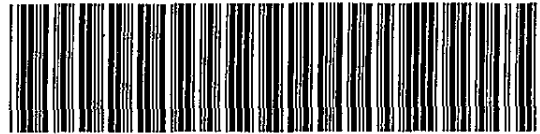



Pursuant to the provisions of Florida Statutes §608.411, Hazen Construction, LLC adopts the following articles of amendment and restatement to its articles of organization:

FIRST: Amendments and restatements adopted:

ARTICLES OF ORGANIZATION

A Florida Limited Liability Company

ARTICLE 1
NAME

The name of this limited liability company is Hazen Construction, LLC.

ARTICLE 2
PERIOD OF DURATION


