**ARTICLES OF ORGANIZATION
OF
CORE PUBLICATIONS, L.L.C.**

The undersigned, pursuant to §608.407, Florida Statutes, adopt the following Articles of Organization for such limited liability company.

ARTICLE I – Name

The name of the limited liability company is CORE PUBLICATIONS, L.L.C.

ARTICLE II – Duration

The period of duration for the limited liability company shall be perpetual.

ARTICLE III – Address

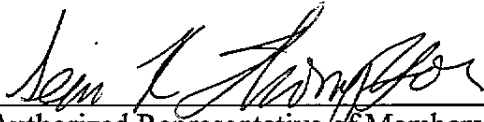
