Article V -- Members

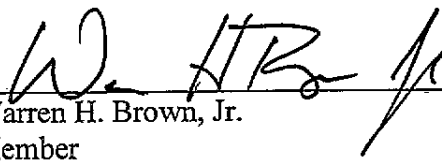

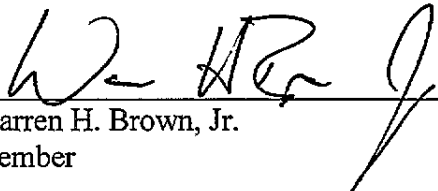

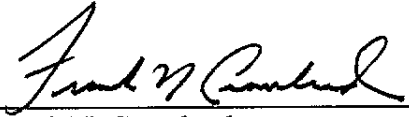
