Additional Provisions**

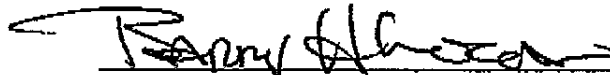
The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managing member of the Company.

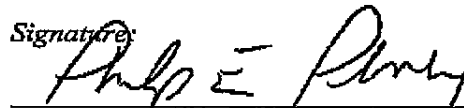

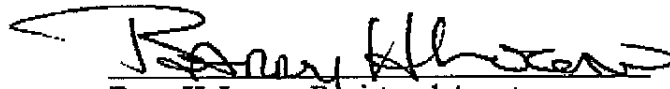
