ARTICLES OF ORGANIZATION

OF

BOTA, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges and files the following Articles of Organization

Article I-Name

The name of the limited liability company shall be BOTA, L.L.C. ("Company").

Article II-Address

Article III-Effective Date

Subject to the provisions of Article 9, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.


Article X - Members
