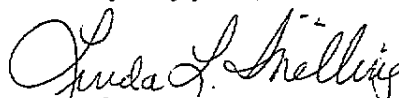

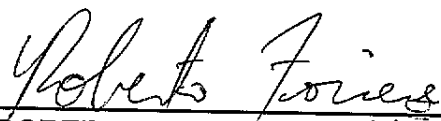
ARTICLE IX

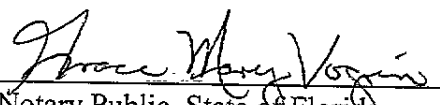
