**ARTICLES OF ORGANIZATION
OF
GULF COAST GROUP OF NAPLES, LLC**

The undersigned, desiring to form a limited liability company (the "Company") under Chapter 608 of the Florida Statutes (the "Act") does hereby state the following:

ARTICLE I
Name

The name of the Company shall be Gulf Coast Group of Naples, LLC.

ARTICLE II
Purpose

The Company shall be formed for the purpose of engaging in all lawful business enterprises, including without limitation, the acquisition, rental and resale of real property.

ARTICLE III
Principal Place of Business
