I respectfully request that your office consider our situation and abate the penalty. We now know our responsibilities for future reporting to the Department of State in a timely manner:

IN NOV 2001, WE FORMED GULF COAST GROUP OF NAPLES LLC. THE LAW OFFICE IN NAPLES HELPING US WITH THE NECESSARY PAPERWORK CLOSED AND TRANSFERRED OUR FILE TO THEIR BOCA RATON OFFICE.

GULF COAST GROUP OF NAPLES LLC WAS ORIGINALLY LOCATED AT 1845 LES CHATEAUX BLVD, NAPLES FL 34109.

IN AUGUST, 2002, WE MOVED TO THE PRESENT ADDRESS IN BONITA SPRINGS. (WE DID NOT KNOW IT WAS NECESSARY TO ADVISE THE FLORIDA DEPARTMENT OF STATE OF A CHANGE OF ADDRESS AND RELIED ON OUR AGENT, BDB, FOR THIS SERVICE.)

IN OCTOBER 2002, THE RENEWAL/REINSTATEMENT NOTICE WAS FORWARDED TO OUR NEW BONITA SPRINGS ADDRESS FROM THE FORMER NAPLES ADDRESS. I COMPLETED AND MAILED THE FORM TO THE REGISTED AGENT (LAW FIRM IN BOCA RATON). MEANWHILE, BECAUSE THE LLC WAS APPLYING FOR A LOAN, THE LENDER INFORMED US WE MUST HAVE A COPY OF THE REGISTRATION CERTIFICATE PRIOR TO LOAN APPROVAL.

I IMMEDIATELY CALLED THE AGENT IN BOCA FOR ASSISTANCE. THEY TOLD ME THEY NEVER RECEIVED THE REWAL/REINSTATEMENT FORM FROM US NOR DO THEY HAVE OUR RECORDS.

I THANK YOU FOR YOUR CONSIDERATION IN THIS INSTANCE. WE ARE NOW AWARE OF OUR RESPONSIBILITIES WITH THE DEPT OF STATE.
