
IN AUGUST, 2002, WE MOVED TO THE PRESENT ADDRESS IN BONITA SPRINGS. (WE DID NOT KNOW IT WAS NECESSARY TO ADVISE THE FLORIDA DEPARTMENT OF STATE OF A CHANGE OF ADDRESS AND RELIED ON OUR AGENT, BDB, FOR THIS SERVICE.)

IN OCTOBER 2002, THE RENEWAL/REINSTATEMENT NOTICE WAS FORWARDED TO OUR NEW BONITA SPRINGS ADDRESS FROM THE FORMER NAPLES ADDRESS. I COMPLETED AND MAILED THE FORM TO THE REGISTERED AGENT (LAW FIRM IN BOCA RATON). MEANWHILE, BECAUSE THE LLC WAS APPLYING FOR A LOAN, THE LENDER INFORMED US WE MUST HAVE A COPY OF THE REGISTRATION CERTIFICATE PRIOR TO LOAN APPROVAL.

I IMMEDIATELY CALLED THE AGENT IN BOCA FOR ASSISTANCE. THEY TOLD ME THEY NEVER RECEIVED THE REWAL/REINSTATEMENT FORM FROM US NOR DO THEY HAVE OUR RECORDS.

I THANK YOU FOR YOUR CONSIDERATION IN THIS INSTANCE. WE ARE NOW AWARE OF OUR RESPONSIBILITIES WITH THE DEPT OF STATE.
