#### AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

# ADHI MANTHRA, L.L.C., a Florida limited liability company

The present name of the Limited Liability Company is Adhi Manthra, L.L.C., which is not being changed. Adhi Manthra, L.L.C., was formed pursuant to the Articles of Organization filed with and accepted by the Florida Department of State on November 20, 2001. These Amended and Restated Articles of Organization have been duly executed and are being filed in accordance with Section 608.411, Florida Statutes, and shall become effective as of 12:01 A.M. (Eastern Time) on September 2012

The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

#### ARTICLE I - NAME

The name of this limited liability company shall be Adhi Manthra, L.L.C. (the "Company").

# ARTICLE II - COMMENCEMENT OF EXISTENCE

This Company commenced existence on November 20, 2001 and shall terminate as provided in the Operating Agreement of the Company.

# ARTICLE III - PRINCIPAL OFFICE MAILING AND STREET ADDRESS

The initial principal office mailing and street address of the Company shall be located at 4420 FM 1960 West, Suite 224, Houston, TX 77068.

### ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

For purposes of service of process within Florida, the initial registered office of this Company shall be located at 250 East Colonial Drive, Suite 300, Orlando, Florida 32801 and the initial registered agent of the Company at that address shall be John Kingman Keating. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.

# ARTICLE V - PURPOSES AND GENERAL POWERS

The Company's business and purpose shall consist solely of the following:

- (a) To engage solely in the ownership, operation and management of the real estate project known as The Palls Apartments located in Hillsborough County, Florida (the "Property"), pursuant to and in accordance with these Articles of Organization and the Company's Operating Agreement; and (b) To engage in such other lawful activities permitted to limited liability companies by
- the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law, as are incidental, necessary or appropriate to the foregoing.

#### ARTICLE VI - INDEPENDENT MEMBER

(a) At all times at which the members of the Company shall take, or shall be required to take, any action in such capacity and until such time as the Loan (hereinafter defined) has been paid in full, there shall be at least one Independent Member (the "Independent Party"). The Independent Party shall be an individual who, except in his or her capacity as an Independent Member of the Company is not, and has not been during the five (5) years immediately before such individual's appointment as an Independent Party, (I) a member, manager, officer or employee of the Company or its Affiliates; (ii) affiliated with a significant customer or supplier of the Company or its Affiliates, or (lii) a spouse, parent, sibling, child or other member of the immediate family of any person described by (I) or (ii) above.

As used herein, the term "Affiliate" shall mean any person or entity other than the Company (I) which owns beneficially, directly or indirectly, any membership interest in the Company, or (ii) which controls or is under common control with the Company. The term "control" means the possession, directly or indirectly, of the power to direct or cause the direction of the management and policies of a person, whether through ownership of voting securities, by contract or otherwise.

- (b) With the consent of the initial members of the Company, which consent the initial members believe to be in the best interest of the members and the Company, no Independent Party shall, with regard to any action to be taken under or in connection with this Article, owe a fiduciary duty or other obligation to the initial members nor to any successor members (except as may specifically be required by statutory law of any applicable jurisdiction), and every member, including each successor member, shall consent to the foregoing by virtue of such member's acquisition of an interest in the Company, no further act or deed of any member being required to evidence such consent. Instead, such Independent Party's fiduciary duty and other obligations with regard to such action under or in connection with this Article shall be owed to the Company (including its creditors). In addition, no Independent Party may be removed until his or her successor has been elected.
- (c) Notwithstanding any other provision of these Articles and any provision of law that otherwise so empowers the Company, the Company shall not, without the consent of

fifty-one percent (51.00%) or more of its members, including the Independent Party, do any of the following:

- (i) engage in any business or activity other than those permitted hereby;
- (ii) do any act which would make it impossible to carry on the ordinary business of the Company, except as otherwise provided in these Articles;
- (iii) borrow money or incur any indebtedness or assume or guaranty any indebtedness of any other entity, other than normal trade accounts and lease obligations incurred in the ordinary course of business, or grant consensual liens on the Company's property; except, however, the manager or managing member, as applicable, is hereby authorized to secure financing (the "Loan") for the Company from BankUnited, N.A., in such amount and on such terms as such manager or managing member may elect, and to grant a mortgage, deed of trust, lien or liens on the Company's property to secure such Loan, as well as incur other indebtedness to the extent expressly authorized pursuant to the documents further evidencing the Loan;
- (iv) dissolve or figuidate, in whole or in part;
- (v) sell or lease or otherwise dispose of all or substantially all of the assets of the Company except in a manner, if any, consistent with the requirements of the documents evidencing the Loan;
- (vi) institute proceedings to be adjudicated bankrupt or insolvent, or consent to the institution or bankruptey or insolvency proceedings against it, or file a petition seeking or consenting to reorganization or relief under any applicable federal or state law relating to bankruptcy, or consent to the appointment of a receiver, liquidator, assignee, trustee, sequestrator (or other similar official) of the Company or a substantial part of property of the Company, or make any assignment for the benefit of creditors, or admit in writing its inability to pay its debts generally as they become due, or take company action in furtherance of any such action;
- (vii) amend Articles V, VI, VII, VIII or IX of the Articles of Organization or any of the related provisions of the Operating Agreement of the Company; or
- (viii) consolidate or merge with or into any other entity.

#### ARTICLE VIII - SEPARATENESS PROVISIONS

The Company shall:

- (a) maintain books and records and bank accounts separate from those of any other person;
- (b) maintain its assets in such a manner that it is not costly or difficult to segregate, identify or ascertain such assets;
- (c) hold itself out to creditors and the public as a legal entity separate and distinct from any other entity;
- (d) hold regular manager and member meetings, as appropriate, to conduct the business of the Company, and observe all other legal formalities;
- (e) prepare separate tax returns and financial statements, or if part of a consolidated group, then it will be shown as a separate member of such group;
- (f) allocate and charge fairly and reasonably any common employee or overhead shared with affiliates;
- (g) transact all business with affiliates on an arm's-length basis and pursuant to enforceable agreements;
- (h) conduct business in its own name, and use separate stationery, invoices and checks;
- (I) not commingle its assets or funds with those of any other person; and
- (j) not assume, guaranty or pay the debts or obligations of any other person.

# ARTICLE IX - EFFECT OF BANKRUPTCY, DEATH OR INCOMPETENCY OF A MEMBER

The bankruptcy, death, dissolution, liquidation, termination or adjudication of incompetency of a Member shall not cause the termination or dissolution of the Company and the business of the Company shall continue. Upon any such occurrence, the trustee, receiver, executor, administrator, committee, guardian or conservator of such Member shall have all the rights of such Member for the purpose of settling or managing its estate or property, subject to satisfying conditions precedent to the

admission of such assignee as a substitute Member. The transfer by such trustee, receiver, executor, administrator, committee, guardian or conservator of any Company Interest shall be subject to all of the restrictions, hereunder to which such transfer would have been subject if such transfer had been made by such bankrupt, deceased, dissolved, liquidated, terminated or incompetent Member. The foregoing provision shall apply to the extent permitted by applicable law.

# ARTICLE XII - NON-LIABILITY AND INDEMNIFICATION

- 12.1 Non-Liability. A Manager of this Company, including any Member who shall be a Managing Member, shall not be personally liable to the Company or its Members for monetary damages for breach of fiduciary duty as a Manager (or Managing Member), except for liability:
  - (a) for a breach of the Manager's duty of loyalty to the Company or its Members;
  - (b) for acts or omissions not in good faith or which involve intentional misconduct or knowing violation of law;
  - (c) for a transaction from which the Manager derived an improper personal benefit; or

Each individual or entity who is or was a Manager (including any Managing Members) of the Company (and the heirs, executor, personal representatives, administrators, successors or assigns of such individual or entity) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that such person is or was a Manager of the Company

("Indemnitee"), shall be indemnified and held harmless by the Company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a Manager or officer existing at the time of such repeal or amendment.

Except as otherwise provided herein, the Company reserves the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment hereto, and any right conferred upon the Members is subject to this reservation, which amendment or repeal shall only be effectuated by the affirmative vote of Members owning more than fifty percent (50%) in interest of all of the membership interests in the Company then outstanding.

#### ARTICLE XIV - ADOPTION OF OPERATING AGREEMENT

The Company shall adopt Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the business and affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608, Florida Statutes.

# ARTICLE XV - HEADINGS AND CAPTIONS

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
