# ARTICLES OF ORGANIZATION

## JAG FL, L.L.C.

1. **COMPANY NAME:** The name of the Limited Liability Company is  
JAG FL, L.L.C. (and other dba's as added to)

The intention of these Articles is to organize a Limited Liability Company (to be taxed as a partnership) with 1 member active and 2 inactive, by the member and the inactive member's Trustees. Members entering into this agreement this 1<sup>st</sup> day of April, 1999, are by and among the Diamond Operational Trust and Fcs Business Holding Trust of Columbus City, Muscogee County, State of Georgia and John A. Gill, Jr. of Columbus City, Muscogee County, State of Georgia, Managing-Member.

2. **DURATION AND BUSINESS PURPOSE:** This company will continue for a period of 30 years. The purpose of this Limited Liability Company is to conduct any or all lawful business for which limited liability companies may be organized, including, but not limited to business intent of providing various technical consulting relating to investment and borrowed income and/or similar services as may be contracted for on wholesale, retail or otherwise to generated clients/customers, lessees and other individuals, companies, or personal, business and/or other organizations, as determined by the members that such need is to be met and sustained by this organization, as future adjuncts to those services as/for originally designed and by the member's Trustees. Notice is made that neither insurance nor banking businesses are intended by this organization. Further notice is herein provided that those Trust members, established above, directly or indirectly beneficiary to or are operating under direction of a non-denominational religious and estate planning organization, therefore the workings this business will be maintained in accordance with directives established by the Trustees of that organization. The L.L.C. herein reserves the right to act in the capacity of any lawful for-profit business for which all efforts and results of same will be forwarded to a single member for accounting and distribution as per the dictates of it's member's, and will retain the option(s) to take full advantage of any and all available resources for the benefit of its members and managers, with an explicit retention of all rights as inured to the Trustees.

3. **ADDRESS OF RECORD and REGISTERED AGENT:** In conjunction with NRS 86-241, the office of the initial registered agent in this state is: 81 ZORAYA AVE APT-A ST. AUGUSTINE, FL and the agent is: KIM DANIELS, for service of process. 32080

4. **PROPERTY TRANSFERS TO THE COMPANY:** Members hereby create the JAG FL Limited Liability Company and transfer or exchange property, such is described on/in Exhibit "A", which is attached hereto and incorporated by reference and signed as accepted/authorized by members and/or their Trustees. The Manager(s) will convey the property described on Exhibit "A", as well as all property hereinafter and all income and all profits earned thereon (collectively called company property) to a specified member who will account for same as well as manage and administer, collect and dispose of the property and/or income to and for the benefit of the beneficiaries of those appropriate members who hold or acquire ownership in this company, or their Trustees. All distributions, therefore, will be transferred to the Diamond Operational Trust, for managerial purposes by the Member Manager and Executive Trustee.

5. **MANAGEMENT:** Pursuant to Florida annotated Code, these articles do hereby state that this company is to be managed by a professional management organization whose owners, managers and employees may or may not be members of the JAG FL Limited Liability Company, but who are contracted by the Trustees. Selection of said organization will be by the appointment of the member's Trustees for this company and/or their Trustees, agents or lawful representatives holding power of authority to do so, under assignment of the Trustees. The street address and name of the management company who will initially serve in that capacity is: 10610 Bridgeport Way SW, Lakewood, Washington, 98499 which are the offices of the Washington registered Limited Liability Company Operational Management, L.L.C., operating under contract with the Trustees. The Operational Management,

**L.L.C.** organization will be installed and retained on a permanent basis and will be dismissed and replaced only upon justifiable cause, i.e.: provable malfeasance, misappropriation of funds or fraud, by and at the option of the Managing-Member and the Trustees.

**6. LIABILITY OF MANAGERS:** The company will hold-harmless the Managing-Member and member's Trustees, who will not be personally liable for loss resulting from an act or omission to act in the execution of the powers conferred by the Articles of Organization, so long as they acted in good faith and legal intent as per the intent of the member's Trustees. No Manager will be personally liable for an act or omission of any person appointed by a Manager or Trustee to assist with the purposes of this company as approved by the members or their Trustees. All persons dealing with this company will look only to the JAG FL Limited Liability Company property/assets for the payment of their claims and every instrument which the managers will be made parties to or on account of which liability may be chargeable, against the company property, will in substance so state such limitation of liability or said instrument be discounted by the manager under that power allowed by the Trustees.

**7. INDEMNIFICATION:** Managers, and, if applicable, Trustees will be indemnified by and receive reimbursement from the company assets against loss, liability, expense or damage arising out of an action or omission to act as manager, except to the extent that such loss, liability, expense or damage will result from his or her willful fraud, malfeasance or misconduct as determined by the Trustees. Indemnity or reimbursement will be limited to the company property, and no member will be personally liable for any such indemnification, which will be under the determination of the major share-holding member's Trust Protector.

**8. AMENDMENTS:** The Articles of Organization may be amended in part or in whole, except that no change may be made in the provisions governing the liability of the managers, or other agents, or the members or their Trustees. An amendment may be considered by the members(s) and may be adopted only upon acceptance by the professional management firm employed to oversee the administration of this organization, by the Trustees.

**9. APPOINTMENT FOR SERVICE OF PROCESS:** The Director or General Officer over Limited Liability Companies and other business organizations, as appointed by and through the Florida Secretary of State, is hereby appointed the agent of this limited liability company for service of process if the registered agent has resigned without a replacement, the registered agent's authority has been revoked or the registered agent cannot be found or served with the exercise of reasonable diligence through notification to the Trustees. This agreement has been accepted by the Manager in the State of Florida and its validity, construction, all rights, powers and immunities by it will be governed by the laws of that state as interpreted and agreed by the Trustees.

**10. SEVERABILITY:** If provisions in this instrument are or prove to be unenforceable, the remaining provisions nevertheless will be carried into effect as approved by the Trust Protector and implemented by the professional managerial firm contracted by the Trustees. Further, aspects of this instrument or accompanying documents found to have insufficiencies in grammatical content, syntax or spelling will continue to carry full effect for the spirit of the creator's intent and will not suffer termination, diminishment or lessening of powers for those insufficiencies, under any circumstances, and that/those intents will be wholly determined by it's then existing manager(s) under the sufferance of the Trustees.
