ARTICLES OF ORGANIZATION

OF

ANTI-POLLUTION ON DEMAND, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be ANTI-POLLUTION ON DEMAND, L.L.C. ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be P. O. Box 832092, Ocala, Florida 34483.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the Florida is Carl Green, 237 N.E. 12th Avenue, Ocala, Florida 34470.

ARTICLE V – ACCEPTANCE AS REGISTERED AGENT

Having been designated as the Registered Agent for ANTI-POLLUTION ON DEMAND, L.L.C., I hereby accept the designation and agree to act as the Registered Agent of said company.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS
