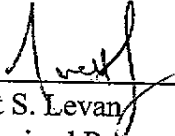

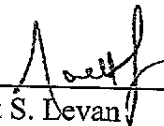
CERTIFICATE OF DESIGNATION OF

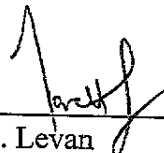
