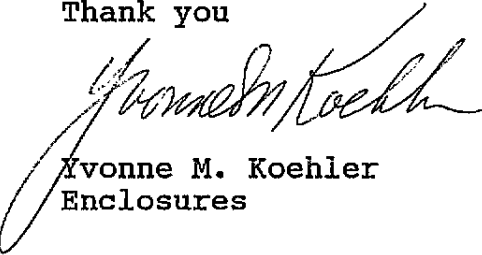

ARTICLES OF ORGANIZATION
FOR
KASSTEPHENS MULTI SERVICES, LLC

ARTICLE I - NAME

The name of this limited liability company shall be:

KASSTEPHENS MULTI SERVICES, LLC.

ARTICLE II - DURATION

This limited liability company shall have perpetual existence.

ARTICLE III - PURPOSE

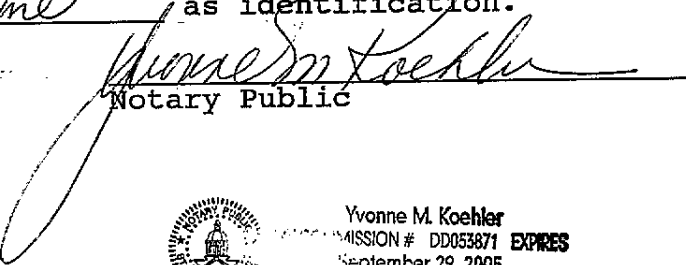
