**ARTICLES OF ORGANIZATION
OF

ARTICLE I - COMPANY NAME

The name of the limited liability company is Rewarding Lifestyles Publications, L.L.C., hereinafter referred to as the "Company".

ARTICLE II - LOCATION


ARTICLE V - INDEMNIFICATION

in their official capacity as Member of the Company, or in their individual capacity, if arising out of the performance of any official management duties.




