AMENDMENT TO

ARTICLES OF ORGANIZATION

OF

GRASS RIVER GROWERS ONE LLC

A Limited Liability Company

Article V of the Articles of Organization dated November 15, 2001 is hereby amended to read as follows:

"ARTICLE V

Management

The LLC is a member-managed company and will be managed by THOMAS F. SCANNELL, III for so long as he is willing and able to render management services.

Such designated managers may be replaced only by unanimous vote of all members.
