Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, **ALEXANDER MEDICAL GROUP, LLC**, a Florida limited liability company (the "Company"), adopts the following Amended and Restated Articles of Organization.

**ARTICLE I**  
**Articles of Organization**

The original Articles of Organization of the Company were filed with the Florida Secretary of State on November 18, 2001.

**ARTICLE II**  
**NAME**

The name of the professional limited liability company shall be **ALEXANDER MEDICAL GROUP, PLLC**.

**ARTICLE III**

**ARTICLE V  
PURPOSE AND DURATION**

The general purpose for which this limited liability company is organized is the conduct of a medical practice as a professional limited liability company pursuant to the Florida Professional Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes) and the transaction of any and all lawful business for which limited liability companies may be organized thereunder, and any amendments thereto, and in connection therewith, this limited liability company shall have and may exercise any and all powers conferred from time to time by law upon limited liability companies formed under such Acts.

This limited liability company shall have perpetual existence.

**ARTICLE VI  
RENDERING OF PROFESSIONAL SERVICES**

This limited liability company shall render the professional services described in Article IV only through its agents, officers, directors, employees and representatives who are duly licensed or otherwise legally authorized in the State of Florida to practice medicine or provide the medical services requested. The term "agents," "officers," "employees," and "representatives" shall not include clerks, secretaries, bookkeepers, technicians, and other assistants who are not usually and ordinarily considered by custom and practice to be rendering professional medical services to the public for which a license or other legal authorization is required.

**ARTICLE VII  
AMENDMENT OF ARTICLES OF ORGANIZATION**

This limited liability company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization from time to time by consent of the members holding a majority of the voting interests of the Company, or otherwise in the manner now or hereafter prescribed in the Company's Operating Agreement, consistent with the laws of the State of Florida."

**ARTICLE VIII  
Date of Adoption**

The Amended and Restated Articles of Organization was adopted on the 6 day of April 2009 by the sole Member.
