

ARTICLES OF ORGANIZATION
OF
STORAGE MANAGEMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I. NAME

The name of the Limited Liability Company shall be **STORAGE MANAGEMENT, LLC.**

ARTICLE II. ADDRESS

ARTICLE III. PURPOSE

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact is any and all lawful business for which a Limited Liability Company may be organized under the Florida Limited Liability Company Act, provided, however, that it shall not engage in any business activity other than that which is directly related to the operation of a storage management company.

ARTICLE IV. DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State and shall exist until thirty (30) years from the date of filing of these Articles of Organization. This company shall be dissolved upon the unanimous consent of the Members.

ARTICLE V. REGISTERED OFFICE AND AGENT

ARTICLE VI. CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash or property as agreed to.

ARTICLE VII. ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.

ARTICLE VIII. ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the

company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE IX. TERMINATION OF EXISTENCE


The company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there are at least two remaining members.

ARTICLE X. MANAGEMENT

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 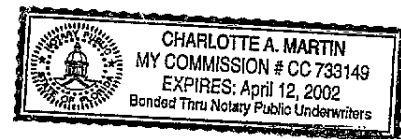
