**ARTICLES OF ORGANIZATION  
of  
HILLTOP DAIRY, LLC  
a Florida limited liability company**

**ARTICLE I  
NAME**

The name of this limited liability company is Hilltop Dairy, LLC (the "Company").

DURATION**

The Company shall commence as of the date of the filing of these Articles with the Secretary of State and shall have perpetual existence.
