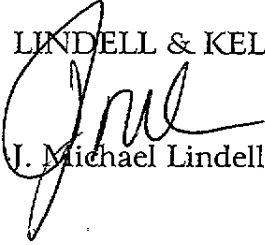

ARTICLE III - DURATION

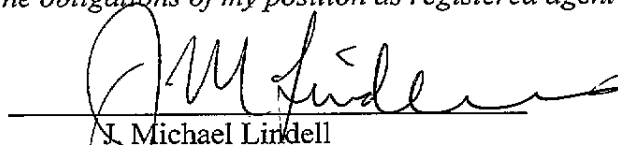
The period of duration for Dale Bolton Enterprises, LLC, shall be perpetual commencing with the filing of these Articles of Organization.
